2007 Scholarship News for Iowa Chapter Members

This spring the Iowa Chapter of CPCU will be awarding two \$1,500 scholarships, one of which is the Ted Lussem Scholarship, to Iowa Chapter members and/or their dependents. This has been a very successful program and we are glad we can continue to offer this opportunity for a scholarship to our members.

To be eligible, applicants must be sophomores, juniors, or seniors attending a four-year accredited college or university in the state of Iowa and maintain an overall G.P.A. of at least 2.75 on a 4.0 scale. Preference will go to students majoring in business and/or an insurance related area of study. Don't forget, if an Iowa Chapter member is currently pursuing a four-year degree, that member is encouraged to apply for the scholarship as well.

The Iowa Chapter of CPCU would like to extend congratulations to Carol on becoming the president of the Independent Insurance Agents of Iowa and best wishes during her term.

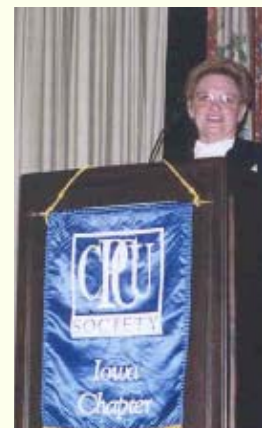

What You'll Learn

Today's business environment poses more and more ethical issues for both management and individual employees. In response to recent events, companies must reaffirm their commitment to ethics, consumer protection, and compliance to business standards. This half-day, interactive course focuses on ethical decision making in the context of insurance by using research, examples, and case studies from the insurance industry. Participants should leave the course with new tools on addressing ethical challenges in the workplace.

- Describe how values impact real business issues/decisions and their benefits and consequences to organizations.

Jones, who also holds the AIC, ARM, and AIS designations, has published articles in the *CPCU Journal*, *National Underwriter*, *Claims* magazine, *Claims Quarterly*, and *Total Quality* newsletter.
