## **Continuing Professional Development (CPD) program**

The CPCU Society and American Institute for CPCU have created the joint Continuing Professional Development (CPD) program, which recognizes professionals who keep their knowledge current and their skills sharp through career-enhancing activities. By participating in this advanced program, you will set yourself apart as a progressive CPCU who is committed to lifelong learning. The CPD program is ideal for CPCUs at every career level, from recent graduates to seasoned professionals.

To qualify for CPD status, you must earn 60 points every two years. (New Designees are pre-qualified for their first two years). Points are awarded for a variety of activities—passing exams or courses, teaching, writing, conducting research, serving in industry organizations, serving as graders or on IIA/AICPCU Exam Review Committees, attending chapter meetings, NLI courses, workshops, and more. The CPD application lists a variety of activities with corresponding point values.

Applying for CPD status is easy! Simply go to our website (www.CPCU-lowa.org), and click on the "CPD On-line" link at the bottom of our home page. This link will take you to the CPCU Society's website and the instructions for completing the CPD application online. The convenience of the application is that you can fill it in, online, as you complete activities. Once you have acquired 60 CPD points, click on the "submit" button, and your application is automatically sent to the American Institute for CPCU where it will be processed.

### The Dirty Dozen: Twelve External Factors Impacting Insurance Contracts

#### What's It About?

The role of the claims professional in determining coverage would be so easy if everything was in black and white! Insurance coverage can be impacted by factors external to the contract which leads to grey areas.
